5. If the building of the school is to be extended, the same should be first approved from Structural Engineer.
6. Adequate Fire safety may be adopted in the school campus.
7. School authority shall also ensure safety precautions from false ceiling and vitrified tiles used in dado.
8. NOC may be considered as cancelled by this office if the school violates any of the above points. This is for your kind information and further necessary action.

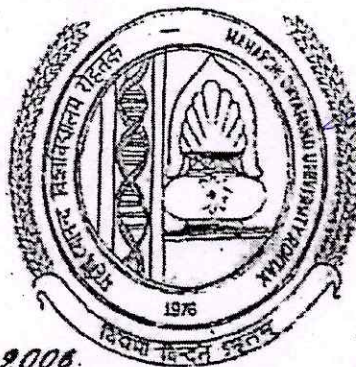
